



COSMOGAS LIMITED WARRANTY

Thank you for your purchase of Cosmogas gas fired appliance products from Hurley Engineering Company of Tacoma, Inc. ("Hurley Engineering"). All Cosmogas products purchased through Hurley Engineering are warranted by Hurley Engineering. Hurley Engineering warrants to the original owner that all parts of this heater which are manufactured by Cosmogas will be free from defects in materials & workmanship under normal use and service for the specified warranty periods and subject to the conditions set forth in this Limited Warranty. Labor charges and other costs for parts removal or reinstallation, shipping and transportation are not covered by this Limited Warranty but are the owner's responsibility. Hurley Engineering shall not be liable for any incidental and consequential damages in connection with a product failure to the extent permissible by applicable law.

The **Effective Date** of this Limited Warranty is twelve (12) months from the date of installation, but no longer than 18 months from the date of purchase from Hurley Engineering.

The **Warranty Period** is ten (10) years for the heat exchanger and one (1) year for all other parts.

The **Warranty Conditions**:

1. Cosmogas appliances must be installed by a licensed installer and meet all national, local & manufacturers standards & codes.
2. A Cosmogas factory trained technician must perform startup & commissioning on all Cosmogas appliances. To ensure warranty consideration, a factory startup report must be completed and submitted to Hurley Engineering.
3. The minimum Maintenance Requirement standards recommended by Cosmogas in the IOM manual must be adhered to in all cases for the warranty to stay intact, including but not limited to preventative maintenance, periodic inspection, annual maintenance & combustion tuning. Refer to the product manual for details.
4. Limitations: The Limited Warranty covers parts only and does not include labor costs to repair or replace the defective part(s). Hurley Engineering's liability under this warranty to the purchaser is limited to the repair or replacement of the failed part (at Hurley Engineering's discretion)

Warranty Exclusions: This warranty does NOT cover failures or malfunctions resulting from:

1. Failure to properly install, operate or maintain the heater in accordance with the product manual;
2. Abuse, alteration of original OEM parts, accident, fire, flood and the like;
3. Ordinary wear & tear, use of product that's unintended.
4. Sediment or lime build-up, freezing or other conditions causing inadequate water circulation;
5. Failure of connected system devices, such as a pump or external controller;
6. Use of non-factory authorized accessories or other components in conjunction with the heater system;
7. Failing to eliminate air from, or replenish water in, the connected water system;
8. Chemical contamination of combustion air or use of chemical additives to system water.
