Original Material Certification: Ensures the proper metal-alloys were specified and supplied for use in all brass components. Trerice products have the PBF (lead-free) symbol marked directly on the mechanical connection.

UL® Certification and listing: UL provides certification to the following standards through a rigorous verification process that includes twice yearly inspection of manufacturing facilities. **TRERICE** is the **Only** manufacturer that meets both NSF/ANSI Standard 372 and 61.

NSF/ANSI Standard 372: Test and certify that the product meets California section-116875/AB 1953 (now Federal) standard of less than 0.25% lead weighted average. Formerly known as NSF/ANSI Standard 61 Annex G, of "The Safe Drinking Water Act". (Lead is the only concern of NSF/ANSI-372 and NSF 61-G)

NSF/ANSI Standard 61 • "Drinking Water System Components": Establishes procedures to test and certify that the product does not leach contaminants (as regulated by the EPA and Health Canada, as well as other non-regulated compounds that would be a health concern into drinking water. (More than just lead)
